All contracts, arrangements and negotiations that arise in the service of any mare designated for the Iowa Breeders Futurity will be strictly between the mare owner and the stallion owner. Stallion owner is responsible for listing all fees beyond normal breeding expenses at the time of the auction. Rules to this Futurity are an attachment to this agreement. Please read and keep for future reference.
