

## 2025 Auction Stallion Owner/Stallion Owner Release Mare Nomination Form IQHA Breeder's Futurity, 2025 Auction-2026 Foal

Stallion must have **sold** thru the 2025 IQHA Breeder's Futurity Stallion Auction.

If breeding is a carryover from a previous year, please use the "2025 Carryover Mare Nomination Form"

**PLEASE NOTE:** This form is for stallion owner slots for stallions that sold in the 2025 Auction. This form & payment needs to be submitted in 2025 regardless if the mare is open or in foal. Please mark the applicable boxes below.

**Only Stallion Owner/Stallion Owner Release's from the 2025 auction need to use this form.**

DO NOT use this form for a purchased breeding, this is only for Stallion Owner slots.

All breedings **purchased** on the 2025 auction included the 2025 mare nomination fee, nothing is due in 2025.

Please mark what type of nomination this is:

- ☐ **Stallion Owner**-stallion must have **sold** in the 2025 auction to nominate a mare/foal for their slot.  
One mare nomination per sold breeding is allowed.
- ☐ **Stallion Owner Release**-stallion owner can relinquish their privilege to nominate their slot to another party if the stallion sold in the 2025 auction. \*\*A **signed** copy of the Stallion Owner Release form (available on the website) must accompany this mare nomination, otherwise the resulting foal will not be eligible to show.

**A Stallion Owner/Stallion Owner Release nomination form & fee must be submitted by the nomination deadline before the foal resulting from this breeding is born.**

**If a foal is born in 2026:** You will need to submit a "2026 Entry" or "2026 Show Carryover" form for the resulting foal in 2026 by Aug. 1, 2026 for the lowest fee.

**If the mare doesn't have a foal in 2026:** You will need to submit a "2026 Carryover Mare Nomination" form by Dec. 1, 2026 for the lowest fee.

**If you do not submit the fee with the proper paperwork; the resulting foal will not be eligible to show.**

Please mark one of these 2 options that apply to this mare's nomination (to the best of your knowledge):

- ☐ The mare is in foal as a result of the stallion owner/stallion owner release slot from the 2025 auction.  
\*In 2026 you will need to submit a "2026 Entry Form" or "2026 Show Carryover" form will need to be submitted by Aug. 1, 2026 for the lowest fee.
- ☐ The mare is open and will be re-bred by the same stallion in 2026.  
\*This breeding will be carried over to next year; however, you must return this form along with the \$50 nomination fee in 2025. Next year a "2026 Carryover Breeding Mare Nomination" form will need to be submitted by Dec. 1, 2026 for the lowest fee.

- ☐ Postmarked on December 2-December 31, 2025 **\$75.00**
- ☐ Postmarked January 1, 2026-prior to foal birth **\$100.00\*\***

**\*\*must include a vet certificate stating the mare has not foaled yet**
