- Bylaws

- Finance

 - Kyle DeFreece had spoken with a local firm, they do not have the manpower to cover our needs.
- 2023 IQHA Show Dates were announced for the Mayflower, May 3rd -7th, 2023 and the Fall Classic and Futurity Show, September 20th-24th, 2023. The Denison July show dates are now IQHA owned and need to be used in 2023 to retain them.
