

IQHA Board Meeting Minutes October 23rd, 2023 Iowa Cattlemen's Association, Ames, Iowa

Opening Business:

The Iowa Quarter Horse Association Board of Directors held a regular meeting Tuesday, October 23rd, 2023 at Old Chicago in Ames, Iowa. President Loren Meyer called the meeting to order at 7:05PM.

August minutes: One change recommended and noted by Alex. Bobbi moved and Nick seconded to approve the minutes with the change noted. All present approved and motion carried and minutes were approved.

Mitch arrived at 7:08PM.

Treasurer's report: Alex Eischeid read her Treasurer's Report including the September month end balances, which are attached. To help document that CD's taken out this August and mature in September 2024, the amounts and accounts impacted are noted below:

Old Business:

Fall Classic Recap: Nick Wood held discussions about the success of the Fall Classic, and that he has put together a list of knowledge to help with next year's show. Overall, the show went well and numbers were also good, as Jackie noted that 513 stalls were sold and 1,671 bags of shavings. To help plan for next year, 2024 dates were discussed. Nick moved to hold the Fall Classic & Futurity September 18th-22nd and Kim seconded. All approved and motion carried. Loren will work TNT, AQHA, and ISF Fairgrounds to finalize holding the show for those dates. **Banquet Updates:** Loren noted that Cindy is continuing to work on planning the Banquet for 2024. Cindy is asking for Districts to donate for door prizes and awards at the Banquet. Alex moved for charging \$35/person for a meal at the Banquet and for IQHA to cover the remaining cost of the meal which is an average of \$12/person. Jackie seconded. All approved and motion carried. Loren will check Cindy about the cost and availability of walk-ins for the meal at the Banquet.

Audit Update: Tammi read a letter from the auditor, and that we have received a draft of the agreed upon procedures summary. Loren will make arrangements to pick up the materials from the auditor. The final copy will be handed out at the next meeting.

By-law change proposals: Loren provided copies to the attendees of the recommended bylaw changes complied to Rosalie from submissions. Nick moved to bring Article 6, Section 1 recommended change as a suggested change to the bylaws at the General Membership meeting and Lori seconded. Kim made the suggestion to note the change of bondable to bonded and Nick amended his motion, Lori seconded amended. All approved and motion carried. The mention of secretary-treasurer occurs 4 times, so this change will also update the other two times it occurs (Article 4, Section 1 and Article 5, Section 1). Lori moved to strike the recommended changes to Article 6, Section 7 and to not bring as a suggested change and Jackie seconded. All approved except Cassie and Tammi, who did not vote. Lori moved to bring Article 4, Section 2 recommended change as a suggested change to the bylaws, but strike out Disciplines 3c from the change and Bobbi seconded. All approved and motion carried. Alex moved to bring Article 3 recommended change as a suggested change to the bylaws. Mitch seconded. All approved and motion carried.

Mayflower 2024 dates: Loren reserved May 1-5th, 2024 with TNT, AQHA, and ISF Fairgrounds.

2024 Breeders Futurity and BIF Rules Change Proposals: Rule changes were submitted by Brian. These rules, and the programs will be discussed at the next meeting, of which Loren will invite Brian Hamrick and Kelly Birkenholtz to the next meeting.
