Codi Jo Heesch was on the phone. Guests included Bill Horton, Kelly Birkenholtz and Mark Ebnet. Rosalie Carlson, Brian Hamrick, Loren Meyer and Kim Strong were absent.

President's Report: Tammi congratulated the Iowa youth who showed at the Youth World Show and IQHA members who showed at the NSBA World Show. She also congratulated IQHYA member Elivia Papcun, who was named Iowa State Fair Senior Cowgirl Queen.

July Meeting Minutes: Mary made a motion to approve, seconded by Codi. Minutes were approved with Jackie not voting.

Treasurer's Report: Codi had sent her report by email. There were no questions. The amateur financial report was provided at the meeting.

Social Media: Jennifer reminded everyone the newsletter deadline is the 25th. The email list includes several non-current memberships that she will review and clean up.

OLD BUSINESS

Accounting: Tammi presented the proposals from Integrated Tax & Accounting and Savant Wealth Management. Discussion was held comparing the two. Tammi asked Codi if she were interested in doing the books in a paid position, which Codi declined. After some more discussion, Sarlynn made a motion to contact Savant for 2025 and proceed as long as we didn't have to do a multi-year contract. With a second by Lindsay, motion passed.

Commemorative Gun Raffle: Mary updated that she still is not getting information from the IRS for the document needed to obtain the gambling permit. Jennifer made a motion to push the drawing back to the Fall Classic 2026. With a second by Lori, the motion passed.

Breeders Futurity: Kelly reported entries seem consistent with last year.

Ranch: Mateer reported for Kim. Nominations are up. With 145 yearlings and 133 stallions both reached all-time high nominations. Sponsorships were continuing to roll in and would cover awards. \$17,500 sponsorship from ABI Attachments will be paid to high money earners in the open division. (Tammi confirmed the sponsorship payment had been received.) The new

3-Year-Old Open Box-Drive-Box class has a \$5,000 added money sponsorship by Farm Bureau Agents of Iowa. Prize buckets will be awarded with over \$40,000 in sponsored prizes. The online entry form is nearing completion. Vendors will be set up in Jacobson and Cattle Barn and surrounding outside areas. Trail patterns were coming from Carson Griggs. The Saturday night event will be more exciting with more entries, great food and giveaways with Four e-bikes given away. The committee will be doing show set-up Monday afternoon.

Fall Classic: Tammi reported for Kim. All staff is hired, volunteers are needed for set-up, trail course set-up/tear down, judge's room maintenance, awards pick up, and the Friday evening party. FresH2O is again sponsoring their team tournament. Wilsons are providing staff food. Jackie reported 224 stalls reserved and 516 shavings pre-ordered. The stall office will be located in the Cattle Barn in the southwest corner.

In other comments, Lindsay reported the Heartland Buckskin (IBHA) is looking for ways to collaborate with a show or clinic. Kelly reported on her reconciliation of the ranch horse committee books. Tammi reminded everyone to email their update reports prior to the meetings.

Jennifer made a motion to adjourn, seconded by Mary. Meeting was adjourned at 7:59 PM.
